# REGULATIONS

- 1)Admitted to participate are soloists (except singers) and instrumental groups (duo, trio, etc.) with unlimited number of players and with instruments of any kind.
- 2) The participants have the power to perform the original music scores or free arrangements of them, except in the first selection. If the organic at their disposal is different from the suggested and indicated one's in the list contained in the announcement of the competition, the participants are obliged to present to the board of examiners a copy of their arrangements at the moment of the selection.

The first and second selection will be held in camera.

4)The competition is structured as follows:

#### FIRST SELECTION

a)The enrolled competitors are subject to a first selection, in which they'll have the possibility to perform only one piece that is part of the whole Astor Piazzolla repertoire, preferably chosen from the one's indicated in the following list:

#### SECOND SELECTION - SEMI-FINALE

b)The semi-finalists have to perform one or more free chosen pieces, different than those performed in the first selection and not necessarily contained in the announcement list, but part of the whole Astor Piazzolla repertoire, for a maximum total time of 15 (fifteen) minutes.

Also in this phase the competitors who propose own arrangements are obliged to present to the board of examiners a copy of the arrangements at the moment of the selection.

The nominative of the finalists will be communicated at the end of the selections.

#### THIRD SELECTION - FINAL

c)The competitors admitted to the final selection have to perform only one piece chosen from the one's performed in the foregoing selections.

We'd like to make it clear that only the final selection will be open to the public.



At the end of the selections the winners will be decreed and awards will be granted to them.

The organization has the power to organize the same evening a concerto open to the public and involve the winners to perform in public a piece, previously agreed with the board of examiners.

The listening order of the competitors will be communicated at the end of the registrations. The participants will be informed previously about the settled order and preselection schedule.

- 5)The Jury reserves the right to award the prizes 'ex-aequo' and also to not award the first prize, if the candidates will not reach good marks.
- 6) Jury Members will not be allowed to judge competitors:
  - -to whom they are related family wise:
  - -that have been their pupils during the previous two years of the Competition.
- 7)The producers reserve the right to radio broadcast or telecast in any way exploit all performances, including that of the final concert (if any). These rights will not entail payments of any kind from the producers to the participants.

# 8)Following awards will be assigned to the winners:

- First prize: € 2.000,00 (two thousand euro)
- Second prize: € 1.500,00 (one thousand and five hundred euro)
- Third prize: € 1.000,00 (one thousand euro)
- Criticism Prize

All participants will receive a participation certificate.

9)The application forms (contained in this announcement of competition or downloadable from the websites: www.piazzollamusicaward.com or www.apagani.it - on the "Events" page -), must arrive by September 30, 2009, complete with a photocopy of an identification document and a receipt of payment of € 40,00 (forty euro) by credit card (we accept VISA or MASTERCARD) or by wire transfer.

(Every group member must fill in an application form and pay enrolment fee)

In case of non-payment of the enrolment fee, the candidate/s will not be admitted to the selections. The entrance fee will not be reimbursed by any reason.

The application to the competition entails the unconditional acceptance of the present regulations; the organization of the competition will not be liable for any kind of accident experienced by competitors and/or their related persons and/or equipment during the period of the competition.

10) All legal disputes will be dealt exclusively at the court of MILANO (Italy).
